A. FOI REQUEST APPLICATION AND ACKNOWLEDGEMENT PROCEDURE

- Complete all boxes, with the exception of the box marked FOR MINISTRY USE ONLY.
- 2. a) Complete one request form for each site/property. However, adjacent properties with the same current owner can be submitted as one request.

Example: 1, 3, and 5 Yonge Street could go on the same form. 1 and 2 Yonge Street must go on two separate forms.

A request with an address range WILL BE RETURNED. Example: 1 - 5 Yonge Street.

- b) Include as much information as possible, such as former street names and former township names.
- c) For properties located in municipalities, a municipal address must be provided. If no municipal address exists, please provide a lot and concession address. All requests for properties within the City of Toronto must have a municipal address.
- d) Please note that the Ministry of the Environment cannot search for records based on Pin, Block, Registered Plan numbers, intersections or descriptions in relation to other properties.
- e) For the most comprehensive search, please provide the names of all present and former property owners and tenants.
 - 3. a) A non-refundable application fee of \$5.00 must accompany each request.

Payment options:

- Cheque made payable to: MINISTER OF FINANCE (FOI)
- MasterCard, Visa or American Express. Authority must be provided for <u>each</u> request. A copy of the transaction will be returned to the requester. Credit card payment forms can be found at our website:

Requests cannot be accepted without payment.

- b) For property information requests, we recommend that you pay a \$35.00 deposit. The \$35.00 covers the non-refundable mandatory \$5.00 application fee, a one hour search and the records, if there are 100 pages or less.
- c) If no responsive records are found, the FOI Office will send a no records confirmation letter to the requester.

- 6. The FOI Office has THIRTY CALENDER DAYS to issue a decision. Extensions may be applied for large and complex requests.
