## It's that wonderful time of year again...


Thank you for taking the time to read our newsletter - We hope you find it helpful and informative.

## What is a Heritage Conservation District?

A Heritage Conservation District (HCD) is an area recognized by the municipality and province as having heritage value, and is recognized by the Ontario Heritage Act. This Act provides for the protection and enhancement of groups of properties of heritage value to the community. As such, an HCD maintains the architectural integrity of a neighbourhood and helps maintain property and cultural value.

## QUESTIONS ABOUT RENOVATIONS OR ALTERATIONS?

#### **DO I NEED A PERMIT?**

If you are a property owner in the HCD and are considering any exterior renovations or repairs (even minor) remember to get your 'no fee' Heritage Alteration Permit before you start to avoid delays or a 'stop work' order!

# **Shell Gas Station and 775, 777 Waterloo Street**

During a routine site environmental check following a site redevelopment in 2005 Shell discovered the presence of underground hydrocarbons (oil products) that had been spilled or leaked over an undetermined period of time under the site.

A remediation system and a series of testing wells were installed on their property as well as 775 and 777 Waterloo Street that saw contaminated groundwater and soil vapors from the site being removed by suction. Shell's environmental consultants confirm that the system is "operating within design parameters" and that it is "unlikely that the soil and groundwater impacts identified within the study area pose an unacceptable risk for vapour intrusion into buildings at 775 and 777 Waterloo Street."

775 and 777 Waterloo are currently owned by Shell but are under an offer for purchase, that sale potentially being completed early January.



Shell reports the conditions continue to improve and levels of hydrocarbons that they are sampling are reducing. Their operation will continue and they will keep us updated. Watch our website or subscribe to our email newsletter for updates.

## Future Development at Oxford and Waterloo

We were all saddened to lose a heritage home from our neighbourhood in the past year. The home at 764 Waterloo had been boarded up for years, and the owner petitioned the city for a demolition permit. Unfortunately our community was not notified early enough to explore options or develop an opposition to demolition. Since that time, the City will now notify communities of demolition permit applications in Heritage Conservation Districts, but it was too late for the house at 764. Strangely, despite the lengthy notice requirements for rezoning there were very few requirements for demolition.

This appears to be a sad case of demolition by neglect, which happens to many heritage buildings if communities are not alert (see the excellent news article on this topic on our web site). If heritage homes are not maintained, then businesses can claim they are too expensive to repair. It is important that our community stays alert for this property development strategy.

More recently, there is an application to re-zone the properties of 754, 756 Waterloo, and 354 Oxford. The application is to rezone to allow development of a pharmacy business without a drive-through (application OZ-8121; see our website for details). Please make your opinions known to the City Planner on this topic. Many of us think this type of business would be a very good fit, but if we do not voice our opinions the building permit could very well end up approving an unattractive "big-box" design. The Community Association will be working to insist that a new building on this site includes details consistent with a heritage neighbourhood. When Shell redeveloped their property we had great success with them including a peaked and gabled roof on the building and extensive landscaping. We will seek similar design features on the new building, but we need many voices to be heard.

## **DID YOU KNOW?**



Opened in September, 1865, The Hellmuth Boys' College, was located in the blocks bounded by Grosvenor, Waterloo, Wellington and St. James Streets. The College with its ten acre grounds included a cricket field, gymnasium, and five's court. The founder was Dean Isaac Hellmuth, who later became second Bishop of the Diocese of Huron. When the college failed, Bishop Hellmuth converted it into Western University in 1881 hoping to offer faculties in Divinity, the Arts, Law and Medicine. The college, in need of repair was occupied briefly but the faculties survived and grew into the University of Western Ontario.

# A message from our Councillor



In Ward 6, our community associations are critical to the strength of our neighborhoods so I'm very pleased to

participate in the Bishop Hellmuth Community Association newsletter. I welcome the opportunity to offer a few comments as your City Councillor. Planning issues are always important to maintaining integrity in neighborhoods, particularly in Old North. One "wrong decision" can lead to a chain of problems that can last for years. After a year on Community Services Committee, I am back on the Planning Committee for this year.

Hopefully I will be able to offer some insight and good advice in this area. We are also approaching budget season. There is some concern about how we have approached the budget over the last couple of years and the single-minded focus on zero. I'd love to hear your thoughts about this as we enter deliberations for 2013.

The only way to reach a legitimate zero is to make permanent operational cuts to the budget and not simply use

one-time money and reserve funds to get there. Eventually we'll have to have much higher tax increases to cover what has not been permanently removed from the budget. # A message from St. George's Public School



Well before the Canada's Confederation, St. George's Public School was built in 1852 as a log cabin on Kent Street. This school

represented one of the original four wards - St. David's, St. Andrew's, St. Patrick's and St. George's – and was London's most northerly school.

Our city grew until the population had expanded out to Oxford Street, with St. James St. still just a well travelled cow path. Determined parents didn't want to take their children all the way into town to what had evolved as the Union School, a four-room building with one class for each of the wards. They finally convinced

City Council to purchase our current property on Waterloo St. and a two-room school was built to look after our own students in what is now Old North.

The rich history of our school is embedded in all we do. We have enjoyed outstanding community support for the emotional needs of our students and staff, and for supplies and services that enrich our children's lives. Now we have just under 200 students, including 25 students with special needs who flourish in our Developmental Education program. We provide full-day kindergarten and a full array of academics, arts and sports to our students through to grade 8. With outstanding community support we have the best library collection anywhere, excellent computer technology and a SmartBoard in every classroom.

Opportunity abounds in our school.

At 105 years, we have the oldest Home and School Association in Ontario. Our School Council is much newer, but plays an integral role in supporting our school during these complex times. Team U-Knighted is a parent designed vehicle for developing student leadership and empathy. Parent support is wonderful and particularly strong during difficult times.

We are proud to be part of this outstanding community and we wish the Bishop Hellmuth Community Association continued success in preserving our history and heritage.
