To those new to the area, welcome!



What is a Heritage Conservation District?

A Heritage Conservation
District (HCD) is an area
recognized by the municipality
and province as having heritage
value, and is recognized by
the Ontario Heritage Act. This
Act provides for the protection
and enhancement of groups
of properties of heritage value
to the community. As such, an
HCD maintains the architectural
integrity of a neighbourhood
and helps maintain property
and cultural value.

QUESTIONS ABOUT RENOVATIONS OR ALTERATIONS?

DO I NEED A PERMIT?

If you are a property owner in the HCD and are considering any exterior renovations or repairs (even minor) remember to get your 'no fee' Heritage Alteration Permit before you start to avoid delays or a 'stop work' order! Remember all houses require permits whether or not they are individually plaqued.

Renters: Are You Covered?

If you are a tenant in our neighbourhood, please make sure that your landlord has appropriate insurance coverage. The London North Community Association reports that some landlords have only regular homeowners insurance on their rental properties, and this may not provide appropriate coverage in the event of a loss. Tenants should consider getting renter's insurance to cover their personal property and should ask their landlords if they have appropriate insurance coverage.

Property Concerns

Many in the neighbourhood have expressed concern about the state of vacant houses along Oxford Street. As you know, we lost a heritage building to demolition in 2012 at the site of the current Rexall Pharmacy. "Demolition through neglect" is a phrase used to describe the practice of letting heritage buildings fall into a state of disrepair and then applying for a demolition permit. The Community Association has been in contact with the city about the houses on Oxford, and building inspectors


have been on site to ensure the buildings do not become derelict. We will alert the neighbourhood about any meetings on this topic via email and by our website.

This will also be a topic of discussion at the upcoming community meeting on March 9, 7 pm, at St. John the Evangelist Church.

Renewing our urban forest

Many of the trees in our neighbourhood, and in London, are reaching an age where they need to be removed for safety reasons. Did you know that most of the trees on our front yards are property of the city? As trees are removed homeowners can request replacement trees. Visit www.reforestlondon.ca for further information on renewing our urban forest.

If you have a new tree on your property, please make sure to water it deeply especially during its first year. Getting the roots established is important. Even older tress may need water during dry summers. The ReForest London website has great information on tree care, including proper mulching. Note that piling mulch around the trunk of the tree can lead to strangler roots



and/or decay of the bark. The trunk of tree needs air exposure right down to the root collar, so mulch should be placed in a donut around the trunk, not piled up to it.

Keep your trees mulched with about 2-4 inches deep of mulch and about a half-meter around your tree. The mulch helps to keep weeds and grass from growing around the tree, retains moisture, and keeps lawn mowers and weed whackers from the tree. The best way to mulch a newly planted tree is to create a donut shape with the mulch, keeping the mulch from touching the base of the tree. You can also use a plastic O-ring to protect the tree from weed whackers and rodents. Just be sure to remove it when the tree is larger so it doesn't damage the bark.

COMING SOON? RAPID TRANSIT LIGHT RAIL LINE

The city has proposed a rapid transit development for London and both the provincial and federal governments have announced plans to invest in infrastructure. Although plans are not finalized, one current proposal is to build a light rail rapid transit line that will run from Fanshawe College along Oxford Street to Richmond (potentially looping through Old East and then downtown, then north on Richmond to Masonville via the university campus. Trains would run every 8 minutes. Rapid transit bus lanes would run along Richmond south to White Oaks, and west on Oxford to Wonderland. This plan is currently in the Environmental Assessment phase, with plans likely to be finalized in 2016 and the rapid transit system functional in 2020-2025.
